ITEM 1. THE FRANCHISOR, AND ANY PARENTS, PREDECESSORS AND AFFILIATES

To simplify the language in this Disclosure Document, the words “we,” “our,” “us” and “Squeeze In” refer to Squeeze In Franchising, LLC, the franchisor of this business “You” and “your” refer to the person who buys the franchise, whether you are a corporation, Limited Liability Company or other business entity. If you are a corporation, Limited Liability Company or other business entity, certain provisions of this Disclosure Document also apply to your owners and will be noted.

The Franchisor

We were formed in Nevada in 2013 to offer Squeeze In franchises for restaurants. Our principal business address is 5020 Las Brisas Blvd A5, Reno, NV 89523. We do business under our company name and the name Squeeze In Franchising, LLC. We have offered unit franchises since September 25, 2015. We have made Area Representative offerings since March 15, 2015.

The first The Squeeze In Restaurant opened in Historic Downtown Truckee, California in 1974. That Restaurant and other Squeeze In Restaurants are owned and operated by other entities owned and controlled by the managing members of Squeeze In Franchising, LLC. We have other Squeeze In Restaurants located in Sparks, Nevada operating since 2012, two in Reno, Nevada operating since 2010 and 2011, and one in Redwood City, California operating since 2011.

Since 2014, we have offered franchises the right to operate a business focused on the development of a restaurant that offers a high-quality traditional breakfast and lunch fare that includes dozens of specialty omelettes, mimosas and Bloody Marys. The franchise or franchised business does business under the trade name or trademark Squeeze In, and also uses our other related trade names, trademarks, trade dress or logos (our “Marks”). The franchised business is to be operated in a retail location that ranges between 1500-2500 square feet, exceptions must be approved by the franchisor. The franchise operates using our standards, methods, procedures and specifications, called our “System.” We have sold one Franchise at the time of this Disclosure Document.

Our Parents, Predecessors and Affiliates

We do not have any parent companies or predecessors.
