Guests not only get to sign the walls, but choose from a varied menu including dozens of specialty omelettes, usual breakfast items, a wide assortment of soups, sandwiches, burritos and salads, as well as beer, mimosas and great Bloody Marys.

The total investment necessary to begin operations of Squeeze In Franchise is \$190,800 - \$500,000. This includes \$40,000 that must be paid to the franchisor.
