STACK Sports Performance Training, LLC, offers franchises for the establishment and operation of a business involving a distinctive and innovative system for sports-performance training that is suitable for athletes of all ages and skill levels—from beginners to elite amateur and professional athletes. The sports-performance training focuses on improving speed, power, agility, flexibility, coordination, and cardiovascular endurance. The goal of the system is to provide a complete training experience to clients.

The total investment necessary to begin operation of a STACK Velocity Sports Performance franchise ranges from \$27,825 to \$653,500. This includes an Initial Franchise Fee of \$40,000 for a Platinum Territory, \$30,000 for a Gold Territory, \$25,000 for a Silver Territory or \$15,000 for a Bronze territory, which must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
