The franchise offered is a business that provides Health Care Staffing services through providing supplemental health care professionals to medical facilities. This includes all employees and staff types in a medical facility. Franchisees will typically offer these services from a home based location.

The total investment necessary to begin operations of a Star Nursing is \$85,500 to \$126,250. This does include the \$29,999 franchise fee that must be paid to the franchisor or affiliate.

OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN CALIFORNIA THAN IN YOUR OWN STATE.

THE FRANCHISE AGREEMENT STATES THAT CALIFORNIA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

THE FRANCHISE AGREEMENT CONTAINS PROVISIONS THAT LIMIT FRANCHISEE'S RIGHTS AND MAY NOT BE ENFORCEABLE IN CALIFORNIA INCLUDING BUT NOT LIMITED TO A TIME LIMIT TO RAISE CLAIMS AGAINST THE FRANCHISOR, LIMITATION OF DAMAGES AND WAIVER OF JURY TRIAL.

IF FRANCHISOR TERMINATES THE FRANCHISEE AGREEMENT BECAUSE FRANCHISEE BREACHED THE AGREEMENT, FRANCHISOR HAS THE RIGHT TO LIQUIDATED DAMAGES IN THE AMOUNT OF THE TOTAL OF ROYALTY FEES PAID OVER THE LAST 24 MONTHS.

THE FRANCHISOR'S FINANCIAL STATEMENTS DATED JULY 29th 2014, SHOW ONLY \$100 IN ASSETS WHICH IS LESS THAN THE AMOUNT OF YOUR INITIAL INVESTMENT. THIS MAY MEAN THAT THE FRANCHISOR WILL NEED TO USE THE MONEY YOU INVEST FOR ITS OWN PURPOSES AND MAY NOT HAVE THE MONEY TO DELIVER PROMISED SERVICES AND ASSISTANCE TO YOU. THE FRANCHISOR WILL TERMINATE FRANCHISEE IF FRANCHISE IS NOT OPENED IN 90 DAYS. FRANCHISEE IS SUBMECT TO A ROYALTY FEE OF 7% ON GROSS REVENUE PAYABLE MONTHLY.

THE FRANCHISOR DOES NOT HAVE FEDERAL REGISTRATION OF IT'S PRINCIPLE TRADEMARK WITH THE USPTO AND THAT IF AN ALTERNATIVE TRADEMARK MUST BE ADOPTED AS A RESULT, IT MAY INCREASE YOUR EXPENSES. THE FRANCHISOR HAS BEEN OFFERING FRANCHISES FOR A SHORT PERIOD OF TIME. THEREFORE, THERE IS ONLY A BRIEF OPERATING HISTORY TO ASSIST YOU IN JUDGING WHETHER OR NOT TO MAKE THIS INVESTMENT.
