The total investment necessary to begin operation of a S.A.F.E. franchise is \$154,850 to \$466,100. This includes approximately \$104,200 to \$371,200 that must be paid to us or an affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. 4. THIS FRANCHISE SYSTEM REQUIRES YOU TO PURCHASE PORTABLE STORAGE CONTAINERS FROM THE FRANCHISOR'S PARENT, AND THE FRANCHISOR'S PARENT DOES NOT HAVE A LONG TERM SUPPLY ARRANGEMENT WITH THE SUPPLIER OF THOSE CONTAINERS.

5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
