We offer franchises for the operation of Street Churros ® churros and dessert restaurants providing premium churros, hotdogs, ice creams and other street food items with a choice of toppings and flavors, as well as other related products and services.

The total estimated investment necessary to begin operation of a single-unit Street Churros® Store franchise ranges from \$93,000-\$352,000. This includes a \$25,000 initial franchise fee that must be paid to us, the Franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendardays before you sign a binding agreement with, or make any payment to, the Franchisor or an affiliate in connection with the proposed franchise sale.
