The Franchise Business you will own and operate is a business that offers advanced certified practitioner-assisted stretching to individuals, which business operates under the trade name “Stretch Zone®.”

The total investment necessary to begin operation of a Stretch Zone Franchise ranges from \$68,100 to \$144,600. This includes \$32,500 to \$43,000 that must be paid to us or our affiliate.

We also offer to certain qualified persons rights to develop 5 Stretch Zone Franchises (the “Franchise Businesses”) within a Development Area under a Stretch Zone Area Development Agreement. You must pay us a Development Fee of \$40,000 (other than for the first Franchise Business that you must purchase at the same time you purchase Area Development Rights). We will credit \$10,000 of the Development Fee against the Initial Franchise Fee for each additional Franchise Business you develop.

This Franchise Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Franchise Disclosure Document and all accompanying agreements carefully. You must receive this Franchise Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, us or an affiliate in connection with the proposed franchise sale or grant. **Note, however, that no governmental agency has verified the information contained in this Franchise Disclosure Document.**

You may wish to receive this Franchise Disclosure Document in another format that is more convenient for you.
