The franchise herein offered grants Franchisees the right to establish and operate a Strings Italian Café Restaurant (also referred to herein as "Strings Restaurant"). As of the date of filing this Circular the Franchise Fee for any Franchisee acquiring a Strings Restaurant Franchise (except for transferred franchises and except for Multi-Unit or Area Franchise arrangements which may provide for lesser franchise fees) is Thirty-Seven Thousand, Five Hundred Dollars (\$37,500).

The estimated cost of a new Strings Restaurant, including Franchisee Fee, will range between \$433,500 and \$516,500.

The Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on the Disclosure Document alone to understand your contract. Read all of your contract carefully. Show your contract and this Disclosure Document to an advisor, like a lawyer or accountant.

Buying a franchise is a complex investment. The information in this Disclosure Document can help you make up your mind.
