A Stroller Spa franchisee will operate a business that cleans, repairs and rents strollers and other baby gear and provides child car seat installation services. Stroller Spa franchises are offered for both mobile units and retail stores

The total investment to begin operation of a *Stroller Spa* business varies with the type of outlet for which you purchase rights. The total investment for a *Stroller Spa* mobile unit is \$40,500 to \$113,900 and for a *Stroller Spa* retail store is \$105,500 to \$235,650 which includes an initial franchise fee store that must be paid to the franchisor of \$25,000 for a mobile unit and \$40,000 for a retail store

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
