This franchise is for the operation of a sports and entertainment management company operating under the "SUN Management Group" name that represents non-exclusive and exclusive clients in sports, entertainment, motivational speaking and fundraising by placing them with end users.

The initial franchise fee is \$25,000 and the required purchases will be approximately \$5,500. The estimated initial investment required ranges from \$74,050 to \$237,750. We may sell development rights to selected individuals or groups.

RISK FACTORS:

- 1. THE FRANCHISE AGREEMENT AND AREA DEVELOPMENT AGREEMENT REQUIRE THE FRANCHISEE TO LITIGATE WITH THE FRANCHISOR ONLY IN TEXAS. OUT OF STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO LITIGATE WITH THE FRANCHISOR IN TEXAS THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT AND AREA DEVELOPMENT AGREEMENT STATE THAT THE LAW OF THE FRANCHISOR'S HOME STATE GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
