We grant franchises that offer targeted advertising services principally to local businesses under the "SuperCoups" name and Marks Our businesses are conducted according to a business concept, format, and operation collectively called the MailCoups System Our targeted advertising services include cooperative direct mail advertising We grant franchises to operate Cooperative Mailing businesses which distribute local and national advertising directly to residences and businesses within specified zip codes We offer distribution of Mailings either directly through us, in which your mailing is sent independently to residences and businesses or to certain markets through other shared distribution programs, to the degree they are available, such as the Valassis RedPlum program or Valassis newspaper alliances

The total investment necessary to begin operation of a Traditional franchise is \$28,750 to \$38,500 This includes \$28,000 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation of a VetFran franchise is \$23,150 to \$32,900 This includes \$22,400 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation of a DiversityFran franchise is \$23,150 to \$32,900 This includes \$22,400 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation of a DiversityFran franchise is \$23,150 to \$32,900 This includes \$22,400 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation of an Industry Experienced Professional franchise is \$19,250 to \$29,000 This includes \$18,500 that must be paid to the franchisor or affiliate.
