We offer franchises for the operation of “Sushi Freak” restaurants offering fresh high quality, customizable, rolled-to-order sushi, salads, soup and other related items, hot tea, fountain drinks, logoed merchandise, as well as beer, wine, and sake on a catering, dine-in and take-out basis.

The total investment necessary to begin operation of a Sushi Freak franchise is ~~\$207,000 to \$266,000~~ ~~184,032 to \$273,616~~. This includes ~~\$25,000~~ ~~19,500~~ that must be paid to the franchisor and ~~\$12,000 payable to its affiliate~~.

~~We also offer to certain qualified people the right to become a Development Agent. A Development Agent solicits and advertises for new franchisees on our behalf and develops and assists franchisees of ours who are operating in the assigned Development Area. The total investment necessary to operate as a Development Agent is \$24,300 to \$349,100. This includes a Development Agent Rights fee that will range from \$19,500 to \$50,000 depending on the size of the development area that must be paid to the franchisor.~~
