The franchisee will engage in the business of owning and operating a SweetDuet Frozen Yogurt & Gourmet Muffins store ("SweetDuet Store") which has the capacity for retail distribution and on-site consumption of self-serve frozen yogurt, muffins, and coffee, and the wholesale distribution of muffins.

The estimated total initial investment for your first SweetDuet Store ranges from \$250,300 - \$352,800, including \$25,000 you must pay the franchisor.

The estimated total initial investment for your Area Development Agreement is from \$32,500 to \$132,500, all of which you must pay the franchisor. That investment is in addition to the initial investment for your SweetDuet Stores.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale or grant. Note, however, that no government agency has verified the information contained in this document.

CURRENTLY, THAT WOULD BE IN DEERFIELD (WHICH IS IN METROPOLITAN CHICAGO, ILLINOIS). IF YOU DO NOT LIVE IN THE CHICAGO, ILLINOIS AREA, ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT. IT MAY ALSO COST YOU MORE TO ARBITRATE IN THE CHICAGO, ILLINOIS AREA.
- 2. THE FRANCHISE AGREEMENT STATES THAT ILLINOIS LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTION AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. THE PROVISION REQUIRING FRANCHISEE TO CONSENT TO ANY SUIT BEING FILED IN ILLINOIS MAY BE SUPERSEDED BY CERTAIN STATE LAW. IF APPLICABLE TO YOUR STATE IT WILL BE ATTACHED AS EXHIBIT P TO THIS FRANCHISE DISCLOSURE DOCUMENT.
- 4. THERE MAY BE A RISK DUE TO THE FRANCHISOR NOT HAVING REGISTERED ITS PRINCIPAL TRADEMARK WITH THE UNITED STATES PATENT AND TRADEMARK OFFICE.
- 5. THERE MAY BE OTHER RISKS GOVERNING THIS FRANCHISE.
