The franchisee will sign a franchise agreement ("Franchise Agreement") to operate a shop under the name "Swirls and Twirls" featuring self-serve frozen yogurt with a variety of toppings and other complementary products. A Swirls and Twirls shop ("Shop" or "Franchised Business") operates using proprietary formulas, techniques, trade dress, trademarks and logos.

The total investment necessary to begin operation of a Swirls and Twirls franchise is 336,000203,420 to 665,750.499,750. This includes between 106,00030,000 to 122,000103,500 that must be paid to the franchisor and/or its affiliate, as appropriate. These amounts include the cost of furniture, fixtures, equipment and technology packages that must be purchased from the franchisor or its affiliate, as applicable.

We may offer to qualified individuals and entities the opportunity to become a multi-unit operator ("Multi-Unit Operator") to establish and operate a <u>certain number<u>three-pack</u> of Shops at specific locations pursuant to individual franchise agreements. If you become a Multi-Unit Operator, you will pay a Multi-Unit Operator fee <u>of \$52,500</u>, <u>which is</u> equal to 100% of the initial franchise fee <u>(see Item 5, below)</u> for the first Shop to be developed, plus a deposit of 50% of the initial franchise <u>feefees</u> for <u>each additional</u> <u>Shopthe other two Shops</u> to be opened under a Multi-Unit Operator agreement. The total investment <u>necessary will vary based on the number of Shops to be opened</u>.</u>

We also offer to qualified individuals and entities the opportunity to become our development agent ("Development Agent") within a specific geographical area. A Development Agent will act as our agent in a specific area, solicit new franchisees, assist existing franchisees, and conduct inspections of Shops in the geographic area, among other things. A Development Agent must pay us a fee of between \$100,000 and \$250,000. We will pay a Development Agent a portion of royalty fees collected and a portion of initial franchise fees.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

- 1. THE FRANCHISE AGREEMENT, THE MULTI-UNIT OPERATOR AGREEMENT AND THE DEVELOPMENT AGENT AGREEMENT REQUIRE YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION AND LITIGATION ONLY IN NEW YORK. OUT OF STATE ARBITRATION AND LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO ARBITRATE AND LITIGATE WITH US IN NEW YORK THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT, THE MULTI-UNIT OPERATOR AGREEMENT AND THE DEVELOPMENT AGENT AGREEMENT STATE THAT NEW YORK LAW GOVERNS THE AGREEMENTS, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
