- 2 THE FRANCHISE AGREEMENT AND AREA DEVELOPMENT AGREEMENT PROVIDE THAT THE LAWS OF THE STATE OF CALIFORNIA GOVERN THE AGREEMENTS AND THAT LAW MAY NOT PROVIDE YOU WITH THE SAME RIGHTS AND PROTECTIONS AS YOUR LOCAL LAW YOU MAY WANT TO CONSULT AN ATTORNEY REGARDING COMPARISON OF THESE LAWS

- 5 THE FRANCHISOR HAS BEEN IN EXISTENCE FOR A SHORT PERIOD OF TIME, SINCE APRIL 14, 2014 THEREFORE, THERE IS ONLY A BRIEF OPERATING HISTORY TO ASSIST YOU IN JUDGING WHETHER OR NOT TO MAKE THIS INVESTMENT
- 6 AS A FRANCHISEE, YOU ARE REQUIRED TO MEET A MINIMUM SALES QUOTA AT THE END OF EACH YEAR OF THE PET SALON'S OPERATION UNDER THE FRANCHISE AGREEMENT YOUR FAILURE TO MEET THE MINIMUM SALES QUOTA MAY RESULT IN TERMINATION OF YOUR FRANCHISE AGREEMENT (FRANCHISE AGREEMENT, SECTION 8 9)
- 7 WHILE WE HAVE A FEDERAL REGISTRATION FOR THE TRADEMARK/WORD MARK "SYDNEE'S PET GROOMING," WE DO NOT HAVE A FEDERAL REGISTRATION FOR OUR LOGO (STYLIZED WORD MARK) THEREFORE, THE LOGO TRADEMARK DOES NOT HAVE LEGAL BENEFITS AND RIGHTS AS A FEDERAL REGISTERED TRADEMARK IF THE RIGHT TO USE THE LOGO TRADEMARK IS CHALLENGED, YOU MAY HAVE TO CHANGE TO AN ALTERNATIVE TRADEMARK, WHICH MAY INCREASE YOUR EXPENSES
- 8 THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE
