System4 LLC is engaged in the business of operating, developing and licensing others to use the "System4" process to establish a Facility Services Management (FSM) business in which you will provide a variety of services to commercial businesses and government facilities within your designated territory. You will provide the Authorized Services within a designated area ("Master Territory") in one or both of the following 2 ways ("Delivery System"): (1) through your own employees, and/or (2) through subcontractors with whom you establish a contractual relationship. You are prohibited from offering or selling any subfranchises or unit franchises to provide Authorized Services.

The estimated total investment necessary to begin operation of System4® franchise ranges from \$86,000- \$388,000. This includes \$50,000 to \$300,000 that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

YOU MAY HAVE TO SIGN A NEW AGREEMENT WITH DIFFERENT TERMS AND CONDITIONS IN ORDER TO CONTINUE TO OPERATE YOUR BUSINESS. BEFORE YOU BUY, CONSIDER WHAT RIGHTS YOU HAVE TO RENEW YOUR FRANCHISE, IF ANY, AND WHAT TERMS YOU MIGHT HAVE TO ACCEPT IN ORDER TO RENEW.

Please consider the following RISK FACTORS before you buy this franchise:

1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION ONLY IN OHIO. OUT-OF STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN OHIO.
2. THE FRANCHISE AGREEMENT STATES THAT OHIO LAW (EXCLUDING ITS STATUTES THAT REGULATE UNFAIR AND DECEPTIVE TRADE PRACTICES UNLESS THE FRANCHISE BUSINESS IS OPERATED IN OHIO) GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
3. THE MASTER FRANCHISEE MUST MEET MINIMUM ROYALTY PAYMENTS TO THE FRANCHISOR AND MEET MINIMUM PERFORMANCE OBLIGATIONS. IF THE RESULTS ARE NOT ACHIEVED, THE MASTER FRANCHISE AGREEMENT MAY BE TERMINATED.
4. THE FRANCHISOR'S AUDITED FINANCIAL STATEMENTS DATED DECEMBER 31, 2015 REFLECT THAT CURRENT LIABILITIES EXCEED CURRENT ASSETS. THIS MEANS THAT THE FRANCHISE MAY NOT HAVE THE FINANCIAL RESOURCES TO PROVIDE SERVICES OR SUPPORT TO YOU.
5. YOUR SPOUSE MUST SIGN A DOCUMENT THAT BINDS YOUR SPOUSE TO CERTAIN OBLIGATIONS UNDER THE MASTER FRANCHISE AGREEMENT, INCLUDING THE COVENANTS NOT TO COMPETE AND THE PROVISIONS ON CONFIDENTIALITY. YOUR SPOUSE WILL BE LIABLE FOR THOSE OBLIGATIONS UNDER THE MASTER FRANCHISE AGREEMENT, EVEN THOUGH YOUR SPOUSE HAS NO OWNERSHP INTEREST IN THE BUSINESS.
6. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We use the services of 1 or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source is our agent and represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
