The franchises described in this disclosure document are for the operation of a business selling non-medical in-house services helping others with their daily activities including bathing, house cleaning, companionship and transportation, placement services and personal emergency response services under the name Talem Home CareTM.

The total investment necessary to begin operation of a Talem Home Care™ franchise is between \$105,100 and \$195,400. This includes a franchise fee of between \$44,900 and \$64,900 that must be paid the franchisor.

This disclosure document summarizes certain provisions of Your Franchise Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before You sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
