We are *TAN REPUBLIC FRANCHISE COMPANY, LLC*, an Oregon limited liability company. We offer franchises to qualified individuals to own and operate a *TAN REPUBLIC* franchise under the "*TAN REPUBLIC" "BRONZED NATION" "TAN SOCIETY" and "SKYN NATION"* names, logos, and Service Marks. Our franchisees offer upscale tanning, skin care and related spa services and merchandise to the public under the Service Marks (the "Method of Operation"). The Tan Republic and Bronzed Nation marks identify our tanning business operations and the Skyn Nation marks identify our skin care and beauty treatment business operations. A Co-Branded franchise is a Tan Republic, Bronzed Nation or Skyn Nation franchise operated in connection with another concept, or a franchise in which the Tan Republic and Skyn Nation concepts or the Bronzed Nation and Skyn Nation concepts are operated in connection with each other, purchased with the Co-Branding Addendum to the Franchise Agreement.)

The Initial Franchise Fee is \$37,500 The total estimated initial investment necessary to begin operation of a TAN REPUBLIC or BRONZE NATION tanning franchise or a SKYN NATION skin care and beauty treatment franchise ranges from \$111,000 to \$394,800 Refer to Items 5, 6 and 7 of this Disclosure Document for a full explanation regarding the Initial Franchise Fee, other Fees and the Total Investment

We also offer franchises for Tan Republic Area Developer Franchises. An Area Developer acts as our representative to advertise for and market to prospective franchises of Tan Republic franchises within a territory, and to support the franchises located in that territory. The initial franchise fee ranges from the \$100,000 minimum Area Developer Fee to \$1,000,000 calculated at \$0.20 per person of population. The initial investment ranges from \$153,000 to \$1,172,000 for an Area Developer. In addition, the Area Developer is required to open and maintain in operation at least one Tan Republic unit franchise and incurs related costs.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

You may wish to receive your disclosure document in another format that is more convenient for you.
