The franchisee will operate an upscale, casual restaurant offering a variety of food and a wide selection of local craft brews on tap using the primary name and mark "Tap House Grill Addictive Food/Creative Brews."

The total investment necessary to begin operation of a Tap House Grill Addictive Food/Creative Brews restaurant franchise is \$666,500 to \$2,172,200. This includes \$39,000 to \$49,000 paid to the franchisor.

The total investment necessary to begin operations of an area development business for Tap House Grill Addictive Food/Creative Brews restaurant franchises ranges from \$27,800 to \$45,500 in addition to the cost to establish the first Franchised Restaurant described above. This includes the minimum initial Development Fee paid to the franchisor of \$27,000.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

- 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY LITIGATING ONLY IN ILLINOIS. OUT-OF-STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO LITIGATE WITH US IN ILLINOIS THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT THE LAW OF THE STATE OF ILLINOIS GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

- 4. THE FRANCHISEE WILL BE REQUIRED TO MAKE AN ESTIMATED INITIAL INVESTMENT RANGING FROM \$666,500 TO \$2,172,200. THIS AMOUNT EXCEEDS THE FRANCHISOR'S MEMBERS EQUITY AS OF DECEMBER 25, 2016, WHICH WAS (\$204,512).
- 5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
