As an Area Representative, you will support our unit franchisees in the establishment and operation of a membership-based fitness, martial arts and group exercise center that provides customized physical fitness training programs, utilizing and offering proprietary systems, services and products.

The total investment necessary to begin operation of a Tapout Fitness[®] area representative business is between \$104,200 and \$448,000. This includes between \$100,000 and \$400,000 that must be paid to the franchisor or its affiliate(s).

- 2. THE AREA REPRESENTATIVE AGREEMENT REQUIRES THAT GEORGIA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
