The franchise offered is for the operation of a culinary entertainment and educational experience for kids and families under the name "Taste Buds Kitchen® and using the franchisor's proprietary methods, techniques, trade dress, trademarks and logos

The total investment necessary to begin operation of a single Taste Buds Kitchen franchise is between \$190,070 to \$306,925 This includes \$47,500 that must be paid to the franchisor

We also offer the opportunity for a franchisee to sign an Area Development Agreement that will allow development of additional franchises in a defined area Under an Area Development Agreement the franchisee will not pay the initial franchise fee with the opening of each individual franchise, but will instead pay us a Development Fee for the entire package in accordance with the number of franchises to be developed. The fee for 2 franchises is \$70,000, the fee for 3 franchises is \$90,000, and the fee for 5 franchises is \$125,000. If we agree to offer you more than five franchises there will be an additional initial franchise fee of \$25,000 for each additional franchise to be developed.
