We are TAX CENTERS OF AMERICA, INC an Arkansas corporation We offer franchises to qualified individuals to own and operate a Tax Centers of America franchise under the name "TAX CENTERS OF AMERICA" ® and "TCOA." Our franchisees offer highest quality seasonal federal and state income tax return preparation and filing services and promote related bank loan and financing products to the public under the Service Marks (the "Method of Operation") Some of our franchisees also offer year-round bookkeeping services.

The total investment necessary to begin operation of a TAX CENTERS OF AMERICA® individual unit franchise business is \$20,300 to \$63,550. This includes \$10,000 or \$35,000, at your option, that must be paid to us or our affiliate.

We also offer franchises for you to act as a Tax Centers Area Developer Franchisee An Area Developer acts as our representative to advertise for and market to prospective franchises of Tax Centers of America franchises within a territory, and to support the franchises located in that territory. The initial non-refundable standard area development fee is \$60,000 for at least 50 franchises or 500,000 population. The premium area development fee is \$100,000 for at least 100 franchises or 1,000,000 population. The initial total investment, including franchise fee, ranges from \$113,000 to \$272,000 for an Area Developer. In addition, the Area Developer may, but is not required to, open and operate one or more Tax Centers unit franchises and would incur the related costs.
