You will operate a business that offers tax preparation services. Your services will be offered to working class consumers as well as the self-employed. The Initial Franchise Fee is \$3,500.00 and can be financed for \$1,000 down. The estimated required initial investment ranges from \$1,000 to \$10,000.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you can sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government Franchisee has verified the information contained in this document.

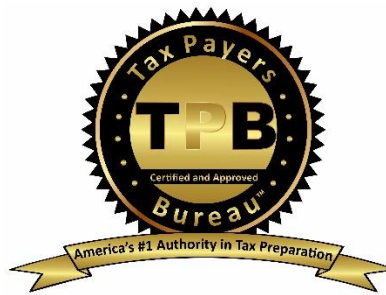
