The franchised business is to offer a realistic competitive simulation experience that could be for fun, sport or tactical training purposes under the trade name Team Combat.

The total investment necessary to begin operation of a Team Combat franchise is \$200,725 to \$726,750. This includes the \$39,000 franchise fee that must be paid to the franchisor or affiliate plus estimated startup costs and cash reserves.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully.
