We offer 3 franchise programs for a start-up Tech Defense franchise:

Multiple Tech Defense businesses. The total investment necessary to begin operation of multiple Tech Defense franchises range from \$52,550 to \$131,400 depending on how many and what combination of Storefront, Kiosk, and Cart units you choose to develop (you may purchase a maximum of three (3) Tech Defense franchise Repair Centers in any combination). The initial franchise fee for the First Unit is \$10,000, Second Unit is \$6,000 and the Third Unit is \$4,000, a total sum of \$20,000 (to develop 3 Tech Defense franchises). The table below illustrates the estimated initial investment for developing multiple Tech Defense businesses.
