The franchise offered is for the operation of a Teeth Tomorrow business, which allows dentists to offer their patients our proprietary dental bridge implantation protocol (“Franchised Business”), under which patients are treated in a two day process to obtain a temporary bridge implant, then receive a permanent bridge implant made of Prettau® Zirconia materials. The total investment necessary to begin the operation of a Teeth Tomorrow Franchised Business is \$47,500 to \$66,000, which includes \$35,000 that must be paid to the franchisor or its affiliate, as appropriate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
