We grant franchises to operate a business (the "TGA-Sports Franchised Business") under the trade name "TGA PREMIER SPORTS" which will provide sports instruction for flag football, floor hockey, lacrosse, ultimate, volleyball and cheerleading in school and after school sports programs, sports clinics, camps, tournaments, parent/child events, ladies clinics and other related activities for these sports for pre-teen and teen age students, youth, adolescents, young adults or adults.

The total investment necessary to begin operation of a TGA-Sports Franchised Business in one protected territory ranges from \$29,800 to \$68,150. This includes \$15,300 to \$42,900, which must be paid to the Franchisor or an affiliate. We also grant development rights which enable you to open multiple TGA-Sports Franchised Businesses within several protected territories. The total investment necessary to begin operation of 2 - 3 TGA-Sports Franchised Businesses in 2 - 3 protected territories ranges from \$49,800 to \$98,150. This includes \$35,300 to \$72,900 that must be paid to the Franchisor or an affiliate for each TGA-Sports Franchised Business.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read the Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payments to the Franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

- 2. THE FRANCHISE AGREEMENT AND MULTIPLE DEVELOPMENT AGREEMENT STATE THAT THE LAW OF CALIFORNIA GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

IF YOU FAIL TO SATISFY THE MINIMUM PERFORMANCE REQUIREMENT DURING ANY YEAR, WE MAY CANCEL YOUR PROTECTED RIGHTS IN YOUR TGA-SPORTS TERRITORY AND MAY SELL ADDITIONAL TGA-SPORTS FRANCHISES WITHIN YOUR TGA-SPORTS TERRITORY, OR WE MAY BEGIN OPERATIONS OF OUR OWN IN YOUR TGA-SPORTS TERRITORY, OR WE MAY TERMINATE YOUR FRANCHISE AGREEMENT.
- 6. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We may use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A FRANCHISE BROKER or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
