Amend Item 21 in the Disclosure Document to disclose this financial information.

Please Note:..your fiscal year end is June 30. Your annual report if application is accepted now would be due in 120 days from June 30 of this year. You may wish to hold off finalizing this initial process till your fiscal year end and submit an audited report. Then you would not have another report due till June of 2012.
