The Barbershop A Hair Salon For Men, LLC welcomes female clients, but the look, products, styles and service offerings are targeted toward male customers. Customers receive quality hair care including cut, shampoo and conditioner, a hot facial towel, eyebrow trim, neck and shoulder massage, and free neck trims between haircuts: Entertainment provided includes television, newspapers and magazines, free coffee, and peanuts.

The total investment necessary to begin operation of The Barbershop A Hair Salon For Men franchise is \$140,275 to \$315,200. This includes an Initial Franchise Fee in the amount of \$30,000 that must be paid to the Franchisor.
