We offer a franchise to own and operate a barre-based fitness and workout studio under "The Barre Code" name and marks.

The total investment necessary to begin operation of a Barre Code franchise ranges from \$198,500 – \$418,800. This includes the Initial Franchise Fee of \$49,500 that must be paid to the franchisor. This also includes the option, if we grant the right to develop multiple units, of entering into a three or five studio Multi-Unit Development Agreement, which has an Initial Franchise Fee of \$108,500 for the combined three-Studios or \$152,500 for the combined five-Studios that must be paid to franchisor.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least fourteen calendar days before you sign a binding agreement with, or make any payments to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
