

The total investment necessary to begin operation of a Beach Hut Deli Franchise will range from \$225,795 228,495 to \$542,415 545,915 For an express location, the total investment will range from \$79,100 to \$245,350 This includes the initial Franchisee Fee of \$35,000 for first time purchasers, \$19,000 for existing BEACH HUT DELI franchisees purchasing an additional traditional, stand-alone franchise and, \$7,500 for an existing Beach Hut deli franchisee purchasing an express franchise location The Franchise Fee is paid to Beach Hut, LLC
