For an express location, the total investment will range from \$79,100 to 246,850 This includes the initial Franchisee Fee of \$35,000 for first time purchasers, \$19,000 for existing BEACH HUT DELI franchisees purchasing an additional traditional, stand-alone franchise, \$20,000 for Ohana Applicants, and, \$7,500 for an existing Beach Hut Deli franchisee purchasing an express franchise location The Franchise Fee is paid to Beach Hut, LLC
