Brass Tap Franchisor, LLC grants franchises for businesses which operate “The Brass Tap®” bars which are upscale beer bars offering craft beers on tap, a large variety of imported, domestic and local craft beers, a large selection of fine wines and other beverage and food offerings. If permitted by applicable law, the Brass Tap® bars also offer cigars and bottled beers for carry out from a package store. The Brass Tap® bars operate using the franchisor’s proprietary formulae, techniques, trade dress, trademarks, service marks, and business systems.

The total investment necessary to begin operations of one The Brass Tap franchise is ~~\$523,885,664,050~~ – ~~\$979,700,1,223,000~~. This includes \$35,000 that must be paid to the franchisor, plus \$17,500 for each additional Brass Tap franchise that you agree to develop under an Area Development Agreement.
