We grant you the right to operate a Buffalo Spot Restaurant. Your Restaurant will offer a variety of flavored wings and buffalo fries, served with our proprietary sauces and other tasty menu items. We also grant to qualified franchisees the right to develop multiple Buffalo Spot Restaurants under a Multi-Unit Agreement.

The total investment necessary to begin operation of a single unit Restaurant is from \$170,800 to \$397,225. This includes the initial Franchise Fee of \$40,000 that must be paid to us upon execution of the Franchise Agreement. The total investment necessary to begin operation under a Multi-Unit Agreement is from \$220,800 to \$497,225. This includes \$50,000 to \$100,000 that must be paid to us as a franchise fee.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information, read it and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the Franchisor or an Affiliate in connection with the proposed Franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

- 1. THE FRANCHISE AGREEMENT AND MULTI-UNIT AGREEMENT REQUIRES YOU TO RESOLVE ANY DISPUTES WITH US BY LITIGATION/ARBITRATION/MEDIATION ONLY IN **ANGELES** COUNTY. CALIFORNIA. OUT OF STATE LOS LITIGATION/ARBITRATION/MEDIATION MAY FORCE YOU TO ACCEPT A **LESS** FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO LITIGATE/ARBITRATE/MEDIATE WITH US IN CALIFORNIA THAN IN YOUR OWN STATE.

- 4. YOUR SPOUSE MUST ALSO SIGN A PERSONAL GUARANTEE MAKING YOUR SPOUSE INDIVIDUALLY LIABLE FOR YOUR FINANCIAL OBLIGATIONS UNDER THE AGREEMENT. THE GUARANTEE WILL PLACE YOUR SPOUSE'S MARITAL AND PERSONAL ASSETS AT RISK IF YOUR FRANCHISE FAILS.
- 5. THE FRANCHISOR AS BEEN OFFERING FRANCHISES FOR A SHORT PERIOD OF TIME THEREFORE, THERE IS ONLY A BRIEF OPERATING HISTORY TO ASSIST YOU IN JUDGING WHETHER OR NOT TO MAKE THIS INVESTMENT.
- 6. THE FRANCHISEE OR MULTI-UNIT DEVELOPER WILL BE REQUIRED TO MAKE AN ESTIMATED INITIAL INVESTMENT RANGING FROM \$170,800 to \$397,225. THIS AMOUNT EXCEEDS THE FRANCHISOR'S STOCKHOLDERS EQUITY AS OF DECEMBER 31, 2017, WHICH IS \$13,421.
- THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
