The franchise offered is for the operation of The CEO Institute business providing a membership organization for Chief Executive Officers ("CEOs") and senior managers offering management development programs using experiential and applied learning models for delivery of the programs together with networking forums and events and related programs and services.

The total investment necessary to begin operation of The CEO Institute franchise ranges from \$76,100 to \$142,100. This includes one lump sum payment of \$50,000 which must be paid to the franchisor.

You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. - 5. FRANCHISOR'S FUNCTIONAL AND REPORTING CURRENCY IS THE AUSTRALIAN DOLLAR. YOU MUST CONSULT AN EXCHANGE OR CONVERSION RATE TO ASSESS ITS VALUE IN U.S. CURRENCY.
