The Franchisor is Comfy Cow Franchising LLC (hereinafter referred to as "**The Comfy Cow**", "Comfy Cow", "we", "us", or "CC".) We develop, operate, and franchise retail stores utilizing The Comfy Cow System in single-brand stores. Our franchised stores sell Comfy Cow ice cream, related frozen products, and other products.

The total investment necessary to begin operation of a CC franchise ranges from about \$259,000 on the low end to about \$416,000 on the high end. This includes a range of \$32,500 to \$41,000 in fees and reimbursable expenses that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. NOTE, HOWEVER, THAT NO GOVERNMENTAL AGENCY HAS VERIFIED THE INFORMATION CONTAINED IN THIS DOCUMENT.
