We offer franchises for the operation of businesses operating under "The Eco Laundry Company™" name and marks that provide laundry services, including wash and fold services, dry cleaning services and tailoring services.

The total investment necessary to begin operation of a The Eco Laundry Company business is \$229,700 to \$375,000. This includes between \$30,000 and \$32,000 that must be paid to the franchisor and/or its affiliate, as appropriate. If you are converting an existing business to The Eco Laundry Company business, the total investment necessary is \$77,200 to \$220,000. This includes between \$15,000 and \$17,000 that must be paid to the franchisor and/or its affiliate, as appropriate.

We may offer to enter into multi-unit development agreements to establish and operate a minimum of three Businesses at specific locations under individual franchise agreements. The multi-unit developer must pay a development fee that is equal to 100% of the initial franchise fee for the first Business to be developed, plus 50% of the reduced initial franchise fee for each additional Business to be developed. The total investment will depend on the number of Businesses that a multi-unit developer commits to develop.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
