As a franchisee, you will operate a cannabis business, known as The Green Solution<sup>TM</sup>. This disclosure document offers three types of franchises which include a cultivation franchise, a manufacturing franchise, and a retail franchise. You may operate just one or all three types of franchises.

The total investment necessary to begin operation of a The Green Solution<sup>™</sup> cultivation franchise is between \$1,801,000 and \$5,271,000. This includes the \$1,348,000 - \$4,053,000 that must be paid to the franchisor or affiliate.

The total investment necessary to begin operation of a The Green Solution<sup>TM</sup> manufacturing franchise is between \$1,287,000 and \$2,673,000. This includes the \$1,189,000 - \$1,785,000 that must be paid to the franchisor or affiliate.

The total investment necessary to begin operation of a The Green Solution<sup>TM</sup> retail franchise is between \$578,000 and \$1,643,000. This includes the \$480,000 - \$880,000 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate regarding the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
