The Franchisor is THE GUN CLEANERS, LLC (the "Gun Cleaners" "we" or "TGC"). Our franchised stores sell memberships to "The Gun Cleaners", which stores provide our proprietary gun cleaning services (the "TGC System"), as well as selling guns, ammunition and accessories. The total investment necessary to open a TGC franchise is between \$49,500.00 and \$151,110.00 per location, including approximately \$35,000.00 that must be paid directly to the franchisor or affiliate.

This franchise disclosure document (or the "Disclosure Document") summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

HOWEVER, CERTAIN TYPES OF DISPUTES, INCLUDING THOSE INVOLVING THE RELEASE OR MISUSE OF TGC'S CONFIDENTIAL OPERATIONS MANUAL, TRADE MARKS OR OTHER PROPRIETARY OR CONFIDENTIAL INFORMATION SHALL BE SUBJECT TO INJUNCTIVE RELIEF IN MCLENNAN COUNTY, TEXAS WITHIN FIVE (5) DAYS NOTIFICATION OF SAID RELEASE OF INFORMATION. OUT-OF-STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMET FOR DISPUTES. IT MAY ALSO COST YOU MORE TO LITIGATE WITH US IN MCLENNAN COUNTY, TEXAS THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT TEXAS LAW GOVERNS THE AGREEMENT. THESE LAWS MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
