The franchise offered is to operate a meat house butchery under the trade name "The Meat House" ("TMH"), providing for the preparation and sale of retail meats, fine cheeses, wine (where laws allow), groceries, prepared foods, and other compatible food items. The total investment necessary to begin operation of a TMH franchise is \$575,086 to \$1,158,586. This includes a minimum of \$105,000 that must be paid to the franchisor or our affiliate.

This is the total sum of all initial fees and payments for services or goods received from the franchisor and its affiliates before the business opens
