Mobile Repair Guys New L.L.C., (“Mobile Repair Guys”) provides on-site small engine and outdoor power equipment repair and maintenance services. The total investment necessary to begin operation of a Mobile Repair Guys franchise is \$88,150 to \$104,150. This includes the initial franchise fee of \$30,000 that must be paid to franchisor or affiliate. The total investment also includes the fully outfitted fourteen foot (14ft) trailer, which is equipped with tools, including, but not limited to, a tool chest, wire welder, air compressor, welding accessories, lawn mower lift and hand tools, and branded with The Mobile Repair Guy artwork so you are able to start your business on day one.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
