Just Turkey Franchise, Inc. is in the business of offering franchises for the operation of restaurants with on-premises and carry-out dining and delivery sales and services, featuring turkey based food products, and food and beverage items authorized by us under the name “THE ORIGINAL JUST TURKEY RESTAURANT.”

The total investment necessary to begin operations of a Just Turkey Restaurant franchise ranges from \$171,500 to \$251,500. The investment may be substantially more if real estate is acquired and/or constructed. This includes the initial franchise fee of \$35,000.00 that must be paid to the franchisor or its affiliate(s). If you execute an Area Development Agreement, there is a fee of \$15,000 for each additional location, in addition to the initial franchise fee for the first location, that must be paid to the franchisor or its affiliate(s).

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

1. THE FRANCHISE AGREEMENT REQUIRES THAT ALL DISAGREEMENTS BE SETTLED BY ARBITRATION IN THE STATE OF ILLINOIS. OUT OF STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN ILLINOIS THAN IN YOUR HOME STATE.
2. THE FRANCHISE AGREEMENT STATES THAT ILLINOIS LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
