THE ORIGINAL **SUPMAN**

Franchisee will operate an outlet that sells proprietary gourmet soups, chili's, stews, desserts, wraps and non-proprietary products like salads, sandwiches, specialty coffees, soft drinks and other beverages. We offer franchises for retail soup locations and co-branded locations.

The total investment necessary to begin operation of an Original Soup Man franchise is \$116,500 to \$357,000 for a stand-alone franchise. This includes \$35,000 that must be paid to the franchisor and/or its affiliate, as appropriate. The total investment necessary to begin operating a SoupMan Mobile Franchise is \$61,500 to \$169,000. That includes a \$15,000 franchise fee that must be paid to the franchisor and/or its affiliate, as appropriate. The total investment necessary to begin operation of an Original Soup Man co-branded franchise is \$62,000 to \$143,000, which will include the majority of our menu offering. This includes a \$20,000 franchise fee that must be paid to the franchisor and/or its affiliate, as appropriate. Except for certain working capital funds needed to begin operations, there is only an initial investment required upon execution of an area development agreement of 50% of the franchise fees required for the number of units in the area development agreement.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale or grant. Note, however, that no government agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind. - 1. THE FRANCHISE AND DEVELOPMENT AGREEMENTS REQUIRE YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION ONLY IN NEW YORK. OUT OF STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO ARBITRATE IN NEW YORK THAN IN YOUR OWN STATE.
