Sadkhin Franchising Company, LLC, a New York limited liability company, offers and sells franchises for the right to independently own and operate a THE SADKHIN COMPLEX franchised business (each, a "Franchised Business" or "Unit") that will offer and provide alternative weight loss programs through hunger control methods

The total investment necessary to begin operation of a single Franchised Business is between \$136,285 and \$247,985, which includes \$64,000 to \$69,000 that must be paid to the franchisor

The total investment necessary to operate multiple Franchised Businesses under our form of area development agreement depends on the number of franchises we grant you the right to open By way of example, the total investment necessary to enter into a development agreement for the right to develop three (3) Franchised Businesses is \$206,285 to \$317,985, which includes (i) a \$130,000 development fee that is paid to us, and (ii) your total investment to begin operation of your initial Franchised Business Your development fee will depend on the number of Franchised Businesses we grant you the right to open within the Development Area, and this fee is calculated as follows (i) \$60,000 for the first Unit you are granted the right to open, (ii) \$40,000 for the second Unit you are granted the right to open, plus (iii) \$30,000 for the third and each additional Unit you are granted the right to open

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
