We offer franchises for the establishment and operation of an advertising publication business, specializing in the production and distribution of high quality advertising guides. We require you to sign a Franchise Agreement, which gives you the right to operate a Scout Guide business in a specific territory under the terms and conditions of the Franchise Agreement. The total investment necessary to begin operation of a new Scout Guide business ranges from \$63,500 to \$70,000. This includes the initial franchise fee of \$50,000.00 that must be paid to us upon the execution of the franchise agreement.

This disclosure document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least fourteen (14) calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on this disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind.
