The franchise offered is to establish and operate a retail THE SOCCER POST Store, offering to the public nationally advertised, name brand soccer equipment, athletic footwear and apparel and related sportswear, accessories, products and services and which may include certain private label items of the franchisor and/or its affiliates and products and services related to other sports.

(1) The total investment necessary to begin operation of a Soccer Post franchise is \$160,000-\$250,000. This includes \$29,500 that must be paid to the franchisor or affiliate.
