Franchisees will establish and operate a business that will manage a chiropractic clinic under the name *The Specific Chiropractic Center*®, which will offer chiropractic services and treatments through professionally licensed chiropractors. The total investment necessary to begin operations ranges from \$24,000 to \$255,000. This includes \$0 or \$25,000 which must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
