I have enclosed an Initial Franchise Registration Application consisting of the following materials:

- 2. Uniform Consent to Service of Process;
- 3. Corporate acknowledgement;
- 4. Franchise Supplemental Information;
- 5. Salesperson Disclosure Form;
- 6. Redline and Clean copies of MBE's 04/30/11 multi-state Non-Traditional Franchise Disclosure Document;
- 7. MBE's Auditor Consent Letter and UPS's (MBE's parent company) Auditor Consent Letter;
- 8. CD-ROM containing the redline and clean Non-Traditional FDD and filing documents;
- 9. A Minnesota Addendum and Amendment;
- 10. Copy of Advertising/Promotional Materials
- 11. A check to cover the applicable filing fee in the amount of \$400.00.

Although the Company currently maintains a franchise registration in the State of Minnesota, that existing filing covers the Company's "Traditional" franchise program. The enclosed documents are for the Company's now separate "Non-Traditional" franchise program, which offers franchises at non-traditional locations as described in Item 1 of the enclosed Disclosure Document.

Document number nine (9) above copies the language found in the Minnesota portion of our State Specific Addendum (FDD Exhibit 5), with a few additions. As in previous years, signature lines are included, confirming that it amends both the Non-Traditional Franchise Disclosure Document and the Franchise Agreement. Second, the section discussing Minn. Rule 2860.4400J states that if we ever seeks injunctive relief against the Franchisee, a court will determine (i) whether or not a bond is required and, if a bond is required, (ii) the amount of the bond. Third, it comes with a "Minnesota Receipt" page, confirming that the Minnesota prospective franchisee has received the Minnesota Addendum and Amendment as a supplement, in compliance with applicable disclosure law timing requirements.
