LB Franchising, LLC ("**LBF**") offers franchises for the operation of premium boutique fitness and non-fitness class venues and multipurpose venue spaces that operate under the "@ the LB<sup>TM</sup>" service mark and feature (i) premium boutique studio space that can be reserved by independent contractors for a variety of fitness and non-fitness classes and training sessions and (ii) premium convertible hospitality space that can be reserved by third parties for hosting community and corporate events, meetings, parties, receptions, and other events (a "**Venue**").

The total investment necessary to begin operation of a new Venue ranges from \$410,280 to \$847,200. This includes \$50,000 to \$79,500 that must be paid to the franchisor or its affiliates. In addition, if you enter into a Development Agreement, you must pay us a development fee equal to \$125,000 to \$300,000 depending on the number of Venues that you commit to developing.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
