INTRODUCTION

I Believe This Is It, Inc. ("the Company" or "the Franchisor") grants franchises known as "This Is It! BBQ & Seafood," ("A Restaurant" or "a Franchised Business") for full service restaurants specializing in Southern home cooking. Some of the most popular items served include Bar-B-Q, seafood, vegetables, desserts, soft drinks, and tea. All of the restaurants in our program must close on Sundays and may not serve alcoholic beverages.

The total investment necessary to begin operation of a This Is It! BBQ & Seafood restaurant ranges from \$625,248 to \$1,050,693 including Additional Funds (as further described in this Disclosure Document) of \$40,000 to \$70,000. The total investment includes the initial franchise fee of \$40,000 for a franchise to be paid to the Company.

Area Developers must pay the Company a fee of \$20,000 for each Restaurant scheduled to be developed under an Area Development Agreement and subsequently pay an additional \$20,000 upon execution of the Franchise Agreement for each such Franchised Business t.

This Disclosure Document ("Disclosure Document") summarizes certain provisions of the Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying documents carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the Franchisor or an affiliate in connection with the proposed franchise sale.

No government agency has verified the information contained in this document.

The terms of your Franchise Agreement will govern your franchise relationship. Do not

Buying a franchise is a complex and important investment. The information in this Disclosure Document can help you make up your mind. OUT OF STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT. IT ALSO MAY COST MORE TO SUE THE FRANCHISOR IN GEORGIA THAN IN YOUR HOME STATE IF YOU DO NOT LIVE IN GEORGIA.
- 2. THE FRANCHISE AGREEMENT STATES THAT GEORGIA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTION AND BENEFITS AS THE LAW IN YOUR STATE. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We pay this person a fee for selling our Franchise or referring you to us. You should make sure to do your own investigation of the Franchise.
